**MINUTES OF THE ALDEBURGH TOWN COUNCIL
MEETING HELD ON MONDAY 14 MARCH 2016
AT 7:00 PM IN THE MOOT HALL**

1. **Apologies:** Apologies had been received prior to the meeting from Cllr Smith – SCC and Cllr Haworth-Culf - SCDC
2. **Councillors' Declaration of Interest**
Cllrs Fox and Harris declared a non-pecuniary interest in items 8bii as Trustees of the Museum.
3. **To Approve the Draft Minutes of the Council meeting held on 8 February 2016**
Minutes of the Council meeting held on 8 February 2016 were **APPROVED**. The Minutes were **APPROVED** and duly signed.
4. **SCC report and Correspondence**
Cllr Smith was not present but had sent a brief report prior to the meeting, copies of this had been circulated to Cllrs. (see Appendix One).
5. **SCDC Report and Correspondence**
Cllr M Jones delivered a report on behalf of herself and Cllr Haworth-Culf (see Appendix Two).

Cllr Walker enquired whether the financial reward of £20 was enough incentive for residents to register to be involved in the Love East Suffolk scheme and commented that this service should already be provided by Norse. Cllr Worster commented that more time should be spent clearing litter from the verges on the main roads.

Cllr Fellowes asked that should the decision be made for Suffolk Coastal and Waveney District Councils to merge will there be a public consultation process implemented to consider public opinion. Cllr M Jones confirmed this proposal is in the early stages of development, any merger could not happen without a lengthy democratic process and include public consultation.

6. **Police Report**
Copies of the Police Report were circulated to Cllrs as the Police were not in attendance. (see Appendix Three).

The Mayor reported that he would be attending a meeting on Thursday 16 March,

arranged by the Neighbourhood Watch group to discuss CCTV in Aldeburgh. Representatives from the Police, the Business Association, the Yacht Club and the Boat Yard have also been invited to attend.

7. PUBLIC FORUM

The Mayor suspended Standing Orders to invite questions from the public gallery.

A resident wished to send their best regards to Cllr Smith.

Another member of the public asked if there had been changes confirmed to the PCSO provision in Aldeburgh and she was advised that the current service level agreement should continue until 31 March 2017 and any changes to this will be reported at a Committee's meeting.

There were no further questions from the Public Gallery and so the Mayor reinstated Standing Orders.

COMMITTEES REPORTS:

8a. PROPERTY & FINANCE COMMITTEE

8ai) Report from Chairman of Property & Finance Committee

Cllr Jones explained that the three businesses invited to tender to repair a number of potholes had submitted their quotes. However, two of the companies have been asked to resubmit them as they had not broken down the repairs into individual jobs as originally requested.

Cllr Jones commented that preparations continue to progress for this year's Sports Week, organisers are exploring funding opportunities, contacting the sports providers in order to finalise the programme of events and ensuring DBS checks are up to date for the volunteers.

Cllr Walker reported that he had been regularly checking the usage of the half pipe skate board ramp on King's Field and had discussed the matter with local children. They confirmed that the ramp is no longer used a great deal and suggested a BMX track on Kemps Field may be a more popular amenity for young people to use. Cllr Walker will continue to monitor usage of this equipment and bring any further suggestions to the Committee's meeting.

Customer Service Improvements at Woodbridge Library

Work has started to develop and upgrade Suffolk Coastal District Council's Customer Services presence in Woodbridge Library.

This is part of our commitment to provide better Customer Services, dealing with issues at the first point of contact, by moving to provide more services in the heart of the community at our current shared facility within Woodbridge Library.

Work on the project started on Monday, 22 February, and should be complete by the end of March.

This investment supports our planned move to new, more cost efficient accommodation in Melton during autumn 2016.

This will effectively create a 'one stop shop' for Council issues at the Library. The improved Customer Service Centre will be the face to face point of customer contact for Suffolk Coastal, with more staff being based at the library and able to deal with more enquiries. Customers will also benefit from services that the library provides including printing services, internet access and free WiFi.

The development will incorporate a new shared helpdesk for library and council staff, a new private interview room and a quieter dedicated area for accessing computers and for reading or study.

The library and Suffolk Coastal Customer Services will remain open during the work, and there should be minimum disruption to customers, but there may be some intermittent noise at various times. We have apologised to customers for any inconvenience during the work.

[Rushmere man given criminal record for waste offence](#)

Suffolk Coastal is reminding householders of their duty of care towards their waste after a Rushmere man was last week found guilty of a waste offence.

A male, of Fellbrigg Avenue, Rushmere St Andrew, appeared at Ipswich Magistrates Court on Tuesday 1 March.

He pleaded guilty to an offence of failing to fulfil his duty of care towards household waste, contrary to Section 34(2A) of the Environmental Protection Act 1990 in December 2014 from his address at the time.

The case was brought to court after ten sacks of fly-tipped waste found on land at Bealings Lane in Hasketon were found to contain post addressed to Mr Adams' home at the time.

When interviewed at his home by Council Officers, he stated that he had allowed an unknown person to remove the ten sacks of unsorted, general household waste that had accumulated in his front garden, and admitted failing to ask what was going to happen to the waste, failing to take any basic details of the identity of the person, and failing to check that the person was an authorised waste carrier.

He had previously been contacted by the Council over concerns about the accumulation of waste in his front garden, and had been offered advice about the correct disposal of the waste. He pleaded guilty and was fined £100. He was also ordered to pay a Victim Surcharge of £20 and contribute £75 towards the Council's costs.

Cllr Poulter, Cabinet Member for the Green Environment, said: "By failing to carry out his basic Duty of Care checks, this individual's carelessness led directly to his waste being dumped in

our countryside. This case serves to show that we will have no hesitation in taking robust action against anyone found responsible for despoiling our beautiful district.

“I would therefore urge anyone who arranges for any waste to be taken away from their home by anyone other than the Council’s service partner Suffolk Coastal Norse (formerly Suffolk Coastal Services) to remember the Scrap Code, to avoid being held responsible should their waste end up fly-tipped.”

- **Suspect.** Beware of rogue waste carriers – reputable companies do not usually make direct approaches. **If in any doubt as to whether someone is a legitimate waste carrier, do not allow them to take your waste.**
- **Check.** Ask for their waste carrier registration details, and verify them by checking the online register or by calling **03708 506 506**. Always note down the registration number of the vehicle used to take your waste away.
- **Refuse** unsolicited offers to have any rubbish taken away. Always carry out your own research and choose who you wish to approach. Legitimate waste carriers are unlikely to seek business by going door-to-door.
- **Ask questions.** Always ask what exactly is going to happen to your rubbish and seek evidence that it is going to be disposed of appropriately. A legitimate, professional waste carrier who wants your business should not object to being asked reasonable questions.
- **Paperwork.** Make sure you get a proper receipt containing the written information for your waste. This should include what has been removed, and where it will be going. Make sure the Company or tradesman’s details are included.

The Suffolk Waste Partnership has produced a video aimed at householders, emphasising the importance of the Duty of Care and how to do their bit to prevent their waste ending up fly-tipped by rogue waste carriers and avoid risking a fine of up to

Further Transformation in East Suffolk

The future working relationship between Suffolk Coastal and Waveney District Councils is being examined – with the possibility of a merger being explored. Suffolk Coastal and Waveney District Councils have been working increasingly closely, since appointing a joint Chief Executive in 2008. This partnership has been key to the Councils’ ability to make £16million efficiency savings since 2008.

Now, at a Simultaneous Cabinet Meeting on Monday, 14 March, leading councillors from both Councils will consider a report examining all the options for the future from forming a wider partnership with one or more other district/borough councils through to formally merging Suffolk Coastal and Waveney into a single district council for East Suffolk.

The report concludes: ‘Both councils are committed to ensuring that East Suffolk is in the best possible position to respond to, and take advantage of, these emerging opportunities and challenges.....The Cabinets are now asked whether they want SMT (the joint Senior Management Team) to develop a draft business case for the formal merger of the two district councils.’

It is stressed these proposals are still at a very early stage. Any merger could not happen without a lengthy democratic process, including public consultation, which would run until 2019 at the earliest.

Nuclear conference held in Suffolk

Senior representatives from 'new nuclear' local authorities across England and Wales gathered in Suffolk last week to discuss common issues relating to the development of new nuclear power stations. Delegates at the NNLAG (New Nuclear Local Authorities Group) conference also heard from Lee McDonough, Director of the Office of Nuclear Development, who highlighted the importance of "communities being at the heart of these developments" and what local authorities can do to support them.

Addressing the conference Ms McDonough highlighted some key elements that are central to supporting local areas to make the most of benefit from the proposed new nuclear developments:

- Early and strong engagement with local businesses and education providers
- Identify workforce requirements both nuclear/non-nuclear specific
- Establish a strong link between Government and local stakeholders
- Develop an evidence-based community offer or project which meets the needs of developer, Government and local community

Lee McDonough said: "Communities are at the heart of these developments and it is therefore absolutely right that they stand to get a large share of the benefits associated with them. It is also important that we make the most of these developments for UK Plc. Therefore, we are working with developers to encourage them to be open and transparent about their procurement plans to enable small and medium size business to get themselves in the strongest possible position to bid for high value contracts."

Whilst each of the proposed developments is at a different stage there were some common themes across members councils:

- Infrastructure
- Supply chain
- Skills
- Jobs
- Growth
- Impact on and benefits for local communities
- Legacy

As part of the conference Cllr Geoff Holdcroft, deputy leader at Suffolk Coastal District Council was elected NNLAG's new chairman.

Cllr Geoff Holdcroft said: "The main role of a local authority in this process is to lobby the developer and Government to do right by local communities. Together NNLAG has a range of topics it is working on, including applying pressure on the UK Government in relation to funding for Community Benefit for nuclear new build in the future.

"As Chair of the group, I am committed to making sure that we work together and speak with a single voice on matters that are common to us all. Together, we put ourselves in a much stronger position. It is a great privilege to be elected Chair of this extremely important group."

[Less than two months to go for the Scottish Rate of Income Tax \(SRIT\)](#)

The Scottish Rate of Income Tax comes into effect from 6 April 2016. The Scottish rate for 2016 to 2017 has been set at 10%, meaning 10p in every £1 will go to the Scottish Government. Your members may have already received their annual coding notice but if not they soon will. It will include the new 'S' code for Scottish taxpayers.

What they will need to do:

- They need to check with their provider that their payroll software is up to date and ready to apply the new 'S' code.
- If they use HMRC's Basic PAYE tools they will need to make sure they use the latest version which will be published in March 2016.

- They must use the code in RTI that was supplied by HMRC.
- Remember the 'S' code depends on the residential address of the employee. Please encourage employees to tell HMRC if their address changes, as this will help us to correctly identify any Scottish taxpayers and ensure they pay the right amount of tax. They can do this online at GOV.UK.

Update

Website

Work is being carried out on the SCDC website (as per previous report) You may experience some 'glitches' during this period but these should be rectified asap. We apologise if you have any problems whilst changes are being made.

Car Park

As per the update last week to the Mayor, TC and Cllr Digby from TJ. An inspection/investigation was carried out last Tuesday.

There are 2 main issues that need to be addressed, the southernmost end of the car park has a large number of pot holes where past attempts to fill them in have not been that successful. The surface will be scraped, re levelled and a roller put over it to level it up – this should be a more affective short term fix and hopefully carried our prior to the Easter holidays.

The remainder suffers with rain water pooling as identified in Cllr Digbys photos that can't drain away properly. Several test holes were completed during the inspection and it would appear that the semi porous surface material has become heavily silted forming an impermeable crust, impeding natural drainage. In this case it is proposed that the surface could be broken up and excavated, then using a geotechnics membrane & mixing in new aggregates to lay a new free draining surface to assist.

TJ will update the TC when she knows more about time scales and what has been decided etc.

TIC

The TC has been updated via Neil Cockshaw and I have been promised that this will continue. The new agreement for delivery is currently being finalised and it is hoped that an announcement will be made before the end of March.

Full Council – Thursday, 25 February

Budget/Council Tax 2016/17: as mentioned previously. Full Council agreed to put up Council Tax for the first time since 2010. It is important that we explain the reasons for this increase – and the fact we are investing in building a strong and vibrant economy.

While we continue to look for ways of making further efficiency saving, we also need to make sure that we protect frontline services, provide more affordable homes and support economic development. Suffolk Coastal is already the strongest economy in Suffolk. Our new Business Plan and Medium Term Financial Strategy for the next four years focus on how we can invest in our communities to enable them to flourish.

We are slightly increasing our portion of the Council Tax bill for this coming year (2016/17) by just under 2 per cent (1.99% to be exact).

This is disappointing, as we have kept Council Tax frozen at 2010 levels, but it needs to be put into context – the increase will be less than £3 (or about 25p a month) for a Band D property, with their Council Tax rising from £149.40 to £152.37 a year.

The reality is that our funding from central Government has been cut by 40 per cent in the last five years. In the same period Suffolk Coastal also froze its portion of the Council Tax, leading to a reduction in our net budget of £3.7 million.

Now Government is removing the Revenue Support Grant, significantly reducing our core funding by over £2.5 million by the end of this Parliament. Another essential part of our funding, the New Homes Bonus is also likely to be cut. Taken together, funding from these sources reduce from over £3.6m in 2015/16 to around £500,000 in 2019/20.

We recognise that Government is doing this as part of the drive to reduce the national deficit, but on a local level we need to properly fund our services.

We believe that a small increase of £2.97 per annum to our portion of the Council Tax this year will put us in the best possible position to continue to invest in enabling our communities and drive economic development to safeguard the future prosperity of this area.

We are committed to providing grants through each Councillor to help build stronger communities through our successful Enabling Communities Initiative and continuing to collect brown bins (organic waste) for free.

We are also investing £1.68million in creating more affordable homes to ensure people can stay within the communities where they are raised and work.

We are still working to reduce our costs. For example, our move into our new headquarters will be funded by the sale of our existing site at Melton Hill and the sale of Cedar House, so there will be no extra burden on the tax payer. Then we will reap the benefits of a smaller, more efficient building, which will lead to year on year savings in our running costs of up to £500,000 a year.
