MINUTES OF ALDEBURGH TOWN COUNCIL MEETING HELD IN THE MOOT HALL ON MONDAY 8th January 2024 AT 7PM

53. To Receive Councillors' Declarations of Interest

Cllr Lumpkin declared a non-pecuniary interest in the Fairfield Centre Agenda Item 61.1

Cllr Fox declared a non-pecuniary interest in the Fairfield Centre Agenda Item 61.1

Cllr Haworth and Cllr Haworth-Culf declared an interest regarding any LionLink and Sealink issues to be discussed. Cllr Haworth-Culf has a dispensation at Suffolk County Council for related discussions.

Cllr Haworth-Culf declared a non-pecuniary interest as member of The National Trust regarding the Five Estuaries Offshore Wind Farm.

54. Suffolk County Council (SCC) Report and Correspondence:

Further to Cllr Haworth-Culf's report that had been circulated, she highlighted the budget pressures and the difficult decisions SCC are having to make.

Funding is becoming available for councils and schools to claim "Suffolk Safe Place" grant between £4,000 and £15,000. This will be from 24th April 2024.

The charity 'Break' has been chosen to deliver two specialised centres for children in the Bury and Lowestoft areas. This will mean children with extra needs will be able to access the support needed.

Cllr Fellowes asked if it is true that Suffolk receives a smaller percentage of funding than other areas in the UK? If so, she believes we should campaign and address the issue. Cllr Haworth-Culf will find out if this is correct.

55. ESC Report and Correspondence:

Cllr Whitelock's monthly report had been circulated.

There was no mention of NSIPs in the report.

The member of the public expressed his dismay about Marriotts Fishing Hut 5 and how it has been slow progress taking two years for section 25 to be served. Cllr Webster confirmed that Mr Marriott now has until March 31st to reply to the notice. Cllr Fellowes would like reassurance from ESC that due process is followed when vacant and to avoid any future transfer issues.

Sports:

Cllrs Fox, Haworth-Culf and Jones have met with members of the Rugby Club and three architects to obtain quotes for drawings for bringing the changing facilities in the Rugby Pavilion up to the required standard.

Property:

Tractor shed. Cllr Jones is waiting for the plan regarding the trenches.

The Town Clerk has contacted Fenn Wright Estate Agents to say we are nearly ready to start marketing the building for rental.

Allotments. The Deputy Town Clerk is busy processing renewal payments. A few allotments have not been renewed, so we will offer to those on the waiting list. There is some rubbish needing clearance. This will be dealt with at the end of the month when it will be clearer how much there is to clear.

Groundsman's Cottage. Cllr Jones has re-contacted Skales to request that they make contact with Ian Culf who can explain what work is necessary regarding insulation.

Bowls Pavilion. There is a leak in the roof which appears irregularly when the wind is in a certain direction. A contractor is looking into this.

Tennis Courts. We still await a date for the tennis courts contractor to inspect the bottom courts to recommend what is required to rectify the cracks.

Kings field. The Property and Finance Committee sought the council's view

on the possibility of creating an enclosed dog area on Kings Field. There is an area where the skatepark used to be although this can be very wet. The idea may be a way of helping with the problem of dog fouling. A discussion about whether dogs should be on the lead on Kings Field followed but this cannot be enforced without a byelaw. Council agreed for the idea to be investigated further.

ACTION: Town Clerk offered to investigate a similar dog area that has been built in the Ipswich area and will report back.

Hoggs builders have been contacted again to request their report of recommended maintenance work for the Moot Hall, with no response.

60.1 Report from the Chair of the Planning Committee

Since the original Planning Committee response had been submitted in relation to Tofts on Saxmundham Road, many residents and local organisations had objected regarding the jetty. As a result the Planning Committee had reconsidered the application earlier today and an updated decision will be submitted.

The Planning Committee will support the views of ESC Tree Officer regarding a request to fell 2 trees located on Victoria Road / Church Farm Road. As these trees were planted by pupils at Aldeburgh Primary School for the troops returning from the first world war, the Planning Committee have requested trees suitable for the space be re-planted.

The application for Peach House has been refused twice in the past. The Planning Committee stance has not changed since the previous application as the current application is largely the same.

ACTION: Cllr Webster will investigate the bin store on King Street as no more has been heard from the enforcement team.
