a) Application No: DC/24/0193/TCA

Location: 9 Aldeburgh Lodge Gardens Aldeburgh Suffolk IP15 5DP

Proposal: 1no. Group of Sycamore (marked on plan) - Reduce in height by up to 5

metres 1no. Poplar (marked on plan) - Fell **Expiry Date**: Thursday 15th February

Aldeburgh Town Council OBJECTS to this application on the following grounds:

- Black poplar trees Gardner's World: 'There are around 7,000 black poplars remaining in the UK, the majority of which are male. Despite its rare status, black poplars are not protected by Schedule 8 of the Wildlife and Countryside Act 1981, which prohibits picking, uprooting and destruction, or selling and advertising plants for sale.'
- From Suffolk Wildlife Trust: 'The black poplar is a large tree of floodplains, flooded gravel pits and ditches, particularly in England. Despite being an important part of our culture for centuries, it has declined massively.
- Conservation status One of Britain's rarest trees.'
- From the National Trust: 'A key for biodiversity The loss of black poplar from our landscapes would impoverish our landscape and arboricultural history, depleting the UK's tree biodiversity and the creatures that rely on it for their survival'
- From the Woodland Trust: Black poplar is the food plant for the caterpillars of many moths, including the hornet, wood leopard, poplar hawk and figure

of eight. The catkins provide an early source of pollen and nectar for bees and other insects, and the seeds are eaten by birds.

- Within a Conservation area
- Sycamores trees are 5m tall and not yet tall enough to be pollarded
- Concerns about future applications for more trees to be removed
- We concur with the comments of objections by residents.
